



Valley of the Temples Memorial Park – Ching Ming Event Draw

Sweepstakes Terms & Conditions

1. **Eligibility:** This sweepstakes is open only to those who receive an entry form at the Valley of the Temples Memorial Park Ching Ming event who are 18 years of age or older as of the date of entry. The sweepstakes is only open to legal residents of the United States, and is void where prohibited by law. Employees of Valley of the Temples Memorial Park, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, and immediate family members and/or those living in the same household of employees (collectively the “Employees”), are not eligible to participate in the sweepstakes. 4. **How to Enter:** The sweepstakes can be entered by completing an entry at the Valley of the Temples Memorial Park Ching Ming event, 47-200 Kahekili Highway, Kaneohe, HI 96744 Sunday, April 7, 2019 from 10:00 am – 12:30 pm. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple entries, email addresses, identities, or devices in an attempt to circumvent the rules.
5. **Prizes:** The Winner of the sweepstakes will receive one (1) \$250 gift card to Foodland. **ODDS OF WINNING:** 1:1000. No cash or other prize substitution shall be permitted except at Valley of the Temples Memorial Park. The prize is nontransferable.
